Office for Greenville County, Jouth Carolina, in Plat Book D, Page 238, and having, according to a more recent survey recorded in said k.A.C. Office in Plat Book A, Page 120, the following metes and bounds, to-wit:

SEGIMMING at an iron pin on the north side of West Hillcrest Drive (formerly Finley Street) at the joint front corner of Lots Nos. 16 and 17, Section H, and running thence along the joint line of said lots, N. 18-10 E. 150 feet to an iron pin; thence N. 71-50 W. 100 feet to an iron pin; thence N. 71-50 W. 100 feet to an iron pin at the joint rear corner of lots Nos. 18 and 19; thence along the joint line of said lots, J.18-10 W. 150 feet to an iron pin in the north side of West Hillcrest Drive (formerly Finley Street); thence along the north side of West Hillcrest Drive (formerly Finley Street) J. 71-50 E. 100 feet to the point of beginning.
