business in Greenville, S. C.	SEND GREETINGS:
WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-VILLE, in the full and just sum of Nine Thousand and No/100(\$ 9.000.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-	
cured hereby), said note to be repaid with interest at the rate specified therein in installments of

C. Jones, C. E., dated November, 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 97, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Bond Street, joint front corner of Lots Nos. 32 and 33, and running thence along the joint line of said lots, N. 82-00 W. 184 feet to a point in the center of a branch, witnessed by an iron pin 7 feet, more or less, back on line; thence following the meanders of said branch as the line, a traverse line being N. 12-00 W. 93 feet; to a point on the southern side of Charing Cross Road at the end of a culvert; thence along the southern side of Charing Cross Road, S. 88-10 E. 182.5 feet to an iron pin; thence following the curvature of the intersection of Charing Cross Road with Bond Street, the chord being S. 43-10 E. 35.4 feet, to an iron pin on the western side of Bond Street; thence along the western side of Bond Street, S. 1-50 W. 22.4 feet, to an iron pin; thence continuing along the western side of Bond Street, S. 5-11 W. 61.5 feet to the beginning corner."
