NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 5 on plat of Addition to Highview Acres recorded in plat book GG page 122 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Arlene Drive, the joint front corner of Lots Nos. 5 & 6; thence with the joint line of said lots N. 5-30 E. 175 feet to an iron pin; thence 8. 84-30 E. 90 feet to an iron pin corner of Lot No. 4; thence with the line of said lot S. 5-30 W. 175 feet to an iron pin on the north side of Arlene Drive; thence with the north side of said street N. 84-30 W. 90 feet to the beginning corner.
