Seventy-Four and 25/100 - - - - - (\$ 74. 25) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such a monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. "All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 13 of a subdivision known as Swanson Court as shown on a revised plat thereof prepared by C. C. Jones, C. E., November 1, 1962, recorded in the R.M. C. Office for Greenville County in Plat Book YY, at Page 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Swanson Court, joint front corner of Lots Nos. 13 and 14, and running thence with the joint line of said lots. N. 35-30 E. 145 feet to an iron pin; thence continuing N. 35-30 E. 15 feet, more or less, to the center of Richland Creek; thence along the center of Richland Creek as the property line, following the meanders thereof in an easterly direction, the traverse line of which being S. 60-00 E. 81.7 feet; thence leaving Richland Creek and running S, 32-00 W. 12 feet, more or less, to an iron pin in the line of Lots Nos. 12 and 13; thence with the joint line of said lots, S. 32-00 W. 150.6 feet to an iron pin on the northern side of Swanson Court; thence with Swanson Court, N. 56-00 W. 90 feet to the beginning corner."
