NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Rickers, Greenville, near the City of Greenville, on the northwest side of East Perry Road, in Paris Mountain Township, containing .25 acre, more or less, and being more fully described as follows: BEGINNING at corner of Paul Miller's lot near the northeast corner of garage and running thence North 43-15 East 85 feet to iron pin; thence South 40-20 East 118.6 feet to iron pin on right of way for a street; thence South 44-45 West 100 feet to iron pin, corner of Paul Miller's lot and Smith's Esso Station lot; thence North 33-06 West 118.4 feet to the BEGINNING corner.
