(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to recure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the cortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at any tentore, the sealing and delivery, of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot # 28, of a subdivision known as Wellington Green, as shown on a plat thereof prepared by Piedmont Engineering Service, dated September 1961, recorded in the RMC Office for Greenville County in Plat Book YY at page 29, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern edge of Melbourh Lane, the joint front corner of Lots # 28 and #27, and running thence along the line of these lots S. 31-17 W. 111.4 feet to an iron pin at the joint corner of Lots # 28, #27, and #29; running thence N. 64-09 W. 172.0 feet to an iron pin on the eastern edge of Rollingreen Road; running thence along the eastern edge of Rollingreen Road N. 2-05 E. 101.3 feet to an iron pin at an intersection, which intersection is durved, the chord of which is N. 68-55 E. 32.8 feet to an iron pin on the southern edge of Melbourn Lane; running thence along the southern edge of Melbourn Lane; 200.0 feet to the point of beginning.

This loan is insured by the American Mortgage Insurance Corporation and it is understood and agreed that at the expiration of 10 years from the date of this mortgage, Fidelity Federal Savings and Loan Association may at its option, apply for insurance for an additional five years with American Mortgage Insurance Corporation, and the mortgager will pay to Fidelity Federal Savings and Loan Association a premium for such insurance of 1/2 of 1% of the principal balance then existing, and this agreement and covenant shall be binding on myself, my heirs, successors and assigns.

Kogether with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached; connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixe tures and equipment, other than the usual household furniture, be considered a part of the real estate.
