NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, and being known and designated as Lot No. 45 as shown on a plat of property of C. N. Martin, recorded in Plat Book Feat Pages 102-103, and described as follows:

"BEGINNING at an iron pin on the northeastern side of Highland Drive' at the joint front corner of Lots Nos. 45 and 46, and running thence with the joint line of said lots, N. 48-50 E. 180 feet to an iron pin; thence S. 41-10 E. 82.5 feet to an iron pin in the joint rear corner of Lots Nos. 44 and 45; thence with the joint line of said lots, S. 48-50 W. 180 feet to an iron pin on the northeastern side of Highland Drive; thence with said Drive, N. 41-10 W. 82.5 feet to the beginning corner."
