WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 7.48 acres, more or less, being the same tract of land conveyed to the mortgagor by deed of Lydia Boyce Crumpton & Junius Boyce Coker, Executrices of the State of James D. Boyce, deceased, October 7, 1946, of record in the R. M. C. for Greenville County, S. C., in Deed Book 300, Page 158, to which reference is made for a better description as to lines, corners, distances, etc. There being situate on the within mortgaged premises a frame cottage dwelling where the mortgagor resides and a small concrete block dwelling, also other outbuildings. Said tract of land lying just Northwest of the Village of Fork Shoals and being on the West side of the GreenvillesFork Shoals Road.

It is understood and agreed that this mortgage is junior in lien to a certain mortgage executed by the mortgagor to the said Mrs Volona P. Gray on the 16th day of March, 1961, in the principal amount of \$1,000.00, of record in the said R. M. C. Office in Real state Mortgage Book 852, at page 291, said mortgage is still of full force and effect.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabova described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
