"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Town-ship; on the west side of a County Road in or near the Village of Pelham, being shown as a portion of the property William C.
