NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indepted to the Mortgagor at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being at the Northeast corner of the intersection of Frank Street and Pinckney Street in the City of Greenville, Greenville Township, County of Greenville, State of South Carolina, and being more particularly described as follows:

BEGINNING at an iron pin at the corner of Frank and Pinckney Streets, running thence N. 56 E. with northwestern side of Frank Street 70 feet to a stake at the corner of a lot now or formerly of Bettis; thence along Bettis line N. 34 W. parallel with Pinckney Street 106 feet more or less to a stake at the corner of a lot now or formerly of Arch T. Hardin; thence with the line of the Hardin lot S. 56 W. 70 feet to an iron pin on the northeastern side of Pinckney Street; thence along northeastern side of Pinckney Street S. 34 E. 106 feet more or less to an iron pin on the corner of Frank and Pinckney Streets, the beginning corner.
