NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his accont by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00), to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate in or near the Town of Piedmont and in Grove Township, designated as Lot No. 39 on a plat made by F. E. Ragsdale, dated April, 1962, and August, 1962, entitled, "Whispering Pines Sub-Division" North of Piedmont, S. C.; and having such shape, metes, courses, and distances as will more fully appear by reference unto said plat.

Beginning at a point North 46 degrees 10 minutes West 89.6 feet to an iron pin thence, North 24 degrees 16 minutes East 133.7 feet to an iron pin on Oak Hill Drive thence, South 60 degrees 00 minutes 100 feet to an iron pin on Oak Hill Drive thence, 154.3 feet to the beginning point.
