SEND GREETINGS

WHEREAS, I/we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Nine Thousand, Three Hundred and No. 100 - (\$ 9,300.00...) Dollars (or for tuture advances which may be made hereunder at the option of said passeration, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Seventy and 51/100 - - - - - - - (\$ 70.51 Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 18 years after date. "BEGINNING at an iron pin on the northern side of Holborn Lane, joint front corner of Lots 40 and 41 and running thence along joint line of said lots, N. 5-35 W. 251.9 to a point in a branch, said point being witnessed by an iron pin 10 feet, more or less, back on line; thence following the center of said branch as the line, traverse lines being S. 60-20 W. 40 feet, S. 27-52 W. 100 feet and S. 0-10 E. 140 feet to an iron pin on the northern side of Holborn Lane, joint front corner of Lots 39 and 40; thence along the northern side of Holborn Lane, S. 89-05 E. 105.6 feet to the beginning point.
