"BEGINNING at an iron pin on the western side of Tindal Road at the joint front corner of Lots Nos. 1 and 2, and running thence with the line of Lot, No. 2, N. 82+11 W. 210, 42 feet to an iron pin; thence with the rear line of Lot No. 4, N. 89-19 E. 84.6 feet to an iron pin in the line of Lot No. 13; thence with the line of Lot No. 13, S. 86217 E. 200.75 feet to an iron pin on the western side of Tindal Road; thence with the western side of Tindal Road, S. 3-0'W. 100 feet to the point of beginning; being the same conveyed to me by W.
