as Lot No. 12 on plat of Forrest View by T. C. Adams dated February 19, 1955, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book "II", at Page 105, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Gilstrap Street, joint front corner of Lots Nos. 11 and 12 and running thence along the common line of Lots Nos. 11 and 12, N. 79-21 E. 244 feet to an iron pin, joint rear corner of Lots Nos. 11 and 12; thence along the rear line of Lot No. 12, S. 4-10 E. 100 feet to an iron pin, joint rear corner of Lots Nos. 12 and 13; thence along the common line of Lots Nos. 12 and 13, S. 79-22 W. 234. 2 feet to an iron pin; thence N. 5-36 W. 11.4 feet to an iron pin on the eastern side of Gilstrap Street; thence along said street, N. 10-16 W. 88.6 feet to an iron pin, the point of beginning.
