"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, near Fleasant Grove Baptist Church, and being shown as Lot No. 20 on a plat of property made for John H. Greer by H.S. Brockman, Registered Surveyor, dated July 16, 1957, recorded in Plat Book YP, at page 121, R. H. C. Office for Greenville County, and having the following courses and distances, to-wit:
