NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and rolease unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, School District No. 6-E, on the east side of Mary Street, being known and designated as Lot No. 124, on Map 2, of a subdivision known as "Camilla Park," as shown on plat thereof recorded in the R. M. C. Office ffor Greenville County in Plat Book "M", at Page 85, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Mary Street at the corner of lot No. 125, which point is 150 feet south of the southeast corner of the intersection of Mary Street and France Avenue, and running thence along the line of Lot No. 125, S. 85-11 E. 216 feet to an iron pin at the rear corner of said lot; thence S. 11-02 E. 80.5 feet to an iron pin at the rear corner of lot No. 123; thence along the line of that lot, N. 85-11 W. 224.5 feet to an iron pin at the corner of said lot on the east sided Mary Street; thence along the line of said Mary Street, N. 4-39 W. 80 feet to the beginning corner.
