"All that certainspiece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the south side of the Hammett's Bridge-Brushy Creek Road, and the northeast side of the Pelham Road, between Greer and Brushy Creek Church, containing 5-5/4 Acres, more or less, and being designated as all of the Church property of the said Enoree Fork Baptist Church, including that described in Plat Book "A", page 361, R.M.C. Office for Greenville County, and the School house lot conveyed to said Enoree Fork Baptist Church by deed of School District of Greenville County, S.C., No. 520, recorded in Deed Book 486, page 284, R.M.C. Office for said County, and also that described in other deeds of conveyance included within the boundary belonging to said Church.
