All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, in the City of Greenville, on the Southeastern corner of Hanover Street and Fairview Avenue, in Fair Heights, known and designated as lot No. 22, Block L, on a plat of Fair Heights, which was recorded in the R.M.C. Office for said County and State in Plat Book F, at Page 257, and, according to said plat, being described as follows:

BEGINNING at an iron pin at the Southeast corner of Hanover Street and Fairview Avenue and running thence with said Hanover Street, 139.5 feet to the joint corner of lots Nos. 1 and 22; thence with line of lots 1 and 22, 50 feet to joint corner of lots Nos. 1, 2, 21 and 22; thence with line of lots Nos. 21 and 22, 139.9 feet to Fairview Avenue; thence with Fairview Avenue, 50 feet to the beginning.corner.
