"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Green ville at the southwestern intersection of Sunrise Drive and an unnamed street as shown on a plat entitled Property of Caesar's Head Co. Inc \ dated August 18, 1956 recorded in the RMC Office for Greenville County in Plat Book LL at page 93 and has, according to said plat, the following metes and bounds, to wit:
