Riddle, Surveyor, dated July, 1950, and revised to show the portion hereby conveyed, November 30, 1951, having the following courses and distances to wit: BEGINNING at an iron pin on Scarborough line and running thence N. 38-30 E. 156-feet to a point in center of said county road; thence along the center of road S. 49-15 E. 98-7 pin feet to point in center of road; thence along new line S. 49-05 W. 157.5 feet to iron pin on J.
