Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the North side of West Lee Road (formerly known as Lee Road), near the City of Greenville, in Chicks Springs Township, Greenville County, South Carolina, being shown as Lot No. 30 on Plat of Super Highway Home Sites, prepared by Dalton & Neves, Engineers, May 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "P", Page 53, said lot fronting 80 feet along the North side of West Lee Road and running back to a depth of 192.2 feet on the East side, to a depth of 200 feet on the West side and being 80.1 feet across the rear.
