*WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ---Thirty-Five Thousand and No/100--

DOLLARS (\$35,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Two Hundred Ninety-Five and No/109--- Dollars (\$295.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may licreafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvement thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the eastern side of Montrose Avenue (formerly Babb Avenue) in the City of Greenville, being the western portion of lot 37, as shown on a plat of the Estate of Tully Parabbb, recorded in Plat Book QQ at Pages 162 and 163, and described as follows:

BEGINNING at an iron pin on the eastern side of Montrose Avenue, 488.6 feet north from Cleveland Street, at the corner of lot 36; and running thence with the eastern side of Montrose Avenue, N. 6-50 W. 240.2 feet to a concrete monument at the corner of lot 38A; thence with the line of said lot, N. 83-12 E. 200 feet to Iron pin; thence S. 6-50 E. 244.1 feet to iron pin in the line of lot 36; thence with the line of lot 36, S. 84-17 W. 200 feet to the point of beginning. Being the same premises conveyed to the mortgagor by Catherine F. Merritt by deed to be recorded.

Subject however to an easement five feet in width along the southern line of the property herein conveyed for the installation of a sewer line.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise on be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures in or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, he considered a part of the real estate.
