AEL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter, constructed thereon, situate, lying and being if the State of South Carolina, County of Greenville, known and designated as Lot No. 19, recorded in the R.M. C. Office for Greenville County in Plat Book "EE", at Page 135, and having, according to said plat, the following metes and bounds, to-wit:
