securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville
State of South Carolina: on the eastern side of Oakvale Drive and being known and
designated as a portion of Lots Nos. 44 and 45 of Oakvale Terrace as shown on plat
thereof recorded in the R. M. C. Office for Greenville County in Plat Book "M", at
Page 151 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Oakvale Drive at the joint
