All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in Ward I of the City of Greenville on the North side of Randall Street, being known and designated as part of Lot No. 23, Section A of Stone Land Company, and being more particularly described according to a survey thereof by R. E. Dalton Engineer, in March 19hh, as follows to-wit:
