ALL that lot of land with the buildings and improvements thereon situate on the Southeast side of James Street, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 15 on plat of property of Emma C. Poag, made by Dalton & Neves, Engineers, June 1939, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book K, Page 68, and having according to said plat the following metes and bounds, to-wit:
