"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, beginning at an iron pin on the eastern side of Bahan Street at the joint corner of Lots Nos. 34 and 36 and running thence along the Mine of lot No. 36 S. 88-10 E. 123.1 feet to an iron pin; thence S. 0-42 E. 87.1 feet to an iron pin, thence N. 88-10 W. 123.1 feet to an iron pigs; thence along the eastern side of Bahan Street N. 0-42 W. 87.1 feet to the point of beginning.
