"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, known and designated as Lot No. 5, recorded in the R. M. C. Office for Greenville County in Plat Book "Q", at Page 1, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Pine Street now known as East Bellview Avenue, joint front corner of Lots No. 4 and 5 and running thence along the common line of said lots N. 42-30 E. 329 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot No. 5 S. 45-45 E. 100 feet to an iron pin; thence along the joint line of Lots No. 5 and 6 S. 43-22 W. 328.66 feet to an iron pin on the northeastern side of Pine Street; thence along said Street N. 45-45 W. 100 feet to an iron pin, the point of beginning.
