Office for Greenville County, South Carolina, in Plat Book C at page 238, and having, in the aggregate, according to a more fecent plat prepared by C.O. Riddle, dated October 28, 1963, entitled "Survey for Sarah C. Trammell", the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Tindal Avenue at the joint front corner of Lots Nos. 62 and 63 of Block A, and running thence with the line of Lot No. 62 N. 2-37 W. 189.04 feet to an iron pin on the Southeastern side of Church Street; thence with the Southeastern side of Church Street N. 25-20 E. 78.55 feet to an iron pin at the Southeastern corner of the intersection of Church Street and McKay Street; thence an iron pin at the Southern side of McKay Street N. 89-15 E. 87.55 feet to an iron pin at the joint rear corner of Lots Nos. 64 and 65; thence with the line of Lot No. 65 S. 1-18 E. 199.1 feet to an iron pin on the Northern side of Tindal Avenue; thence with the Northern side of Tindal Avenue S. 89-07 W. 120 feet to the point of beginning.
