Payable in quarterly installments of \$300.00 each on principal on the 6th day of February 1964, and on the 6th day of each May, August, November and February thereafter until paid in full, with interest from date at the rate of six (6%) per cent per annum, to be computed and paid quarterly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and re-leased, and by these presents does grant, bargain, sell and release this the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Kondros Circle, near the City of Greenville, being shown as Lot No. 6 and a portion of Lot No. 5 on a plat of property of Gus Kondros, recorded in Plat Book LL at Page 129, and according to a survey made by R. W. Dalton in April 1958, has the following metes and bounds, to wit:

"BEGINNING at a stake on the western side of Kondros Circle, 550 feet south from Boling Road, and running thence S. 79-50 W. 165 feet to an iron pin; thence S. 10-10 E. 75 feet to an iron pin; thence S. 0-09 E. 63.4 feet to an iron pin at corner of Lot 7; thence with the line of said lot S. 81-02 E. 165 feet to an iron pin on Kondros Circle; thence with the western side of said Kondros Circle N. 0-21 W. 118.3 feet and N. 10-,10 W. 75 feet to the beginning corner."
