six (6) months from the date hereof, and upon demand thereafter,

with interest from the date hereof, at the rate of Five and One-Half (5½%)
percentum until paid; interest to be computed and paid Semi-Annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including ten per cent of the indebtedness as attorney's fee, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That the said mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the terms of said note, and also in consideration of the further sum of Three Dollars to the said mortgagor in hand well and truly paid by the mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Citizens & Southern National Bank, its Successors and Assigns,

"All that certain piece, parcel, or lot of land, with any improvements thereon situate, lying, and being on the northern side of Mapleton Drive, Pine Forest Subdivision, Greenville County, South Carolina, shown and designated as Lots 90 and the westernmost, adjoining one-half (½) of Lot 91, on a plat of said subdivision recorded in the Office of the R.M.C. for said County in Plat Book "QQ", Pages 106 and 107, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the northern side of said Drive, joint front corner of Lots 89 and 90, and running thence N. 26-30-W. 138 feet along the joint line of said lots to an iron pin, joint rear corner of said lots, and Lots 69 and 68; thence N. 63-30-E. 100 feet along the joint line of Lots 68 and 90 to an iron pin, joint rear corner of said lots and Lots 67 and 91; thence N. 63-30-E. 50 feet along the joint line of Lots 67 and 91 to a point in the joint rear line of said lots; thence S. 26-30-E. 138 feet along a new line through Lot 91 to a point on the northern side of said Drive, which point is N. 63-30-E. 50 feet from the iron pin at the joint front corner of Lots 90 and 91; thence S. 63-30-W. 150 feet along the northern side of said Drive to an iron pin, the point of beginning.
