"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of All that certain lot or parcel of land, together with building there, situate, lying and being in the state of South Carolina, County of Greenville, better known and described as lot No. 12, Section F of the property known as Woodville Heights, surveyed by W. J. Riddle in December 1948 and recorded in the office of Register of Mesne Conveyance for Greenville County, S.C. in Plat Book "L" at pages 14 & 15, to which plat and the record thereof reference is hereby made.

This lot faces 68.1 ft on Spruce Street, 218.2 ft on the North east; 70 ft in the rear and 215 ft on the South West Side;

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
