"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 1 of the property of J. P. Medlock as shown on an unrecorded plat thereof prepared by R. B. Bruce, R.L.S. dated January 30, 1959 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the southwestern side of Grand Avenue, which point lies S. 20-08 E. 419.3 feet from the intersection of Grand Avenue and Lowndes Hill Road, and running thence with Grand Avenue, S. 20-08 E. 75 feet to a point; thence S. 69-52 W. 120 feet to a point; thence N. 20-08 W. 75 feet to a point; thence N. 69-52 E. 120 feet to the beginning corner; being the southernmost portion of the property conveyed to J. P. Medlock by Wm. R. Timmons, Jr. and W. T. Patrick by deed dated October 11, 1956 and recorded in the R.M.C. Office for Greenville County in Deed Volume 563, at Page 118.
