"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the southwestern side of Hiawatha Drive, being shown as Lot No. 222 on a plat of Sector V Botany Woods, recorded in Plat Book YY at Pages 6 and 7, and described as follows:
