SÉND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of <u>I Welve Thousand and No/100------(\$ 12,000,00)</u> Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

seventy-seven and 32/100-----(\$ 77.32 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. "BEGINNING at an iron pin on the southwestern side of Hope Street, joint front corner of Lots Nos. 28 and 29, and running thence along the joint line of said lots, S. 54 W. 247 feet to an iron pin; thence N. 13-30 W. 100 feet to an iron pin at the rear corner of Lot No. 30; thence along the line of that lot, N. 52 E. 206 feet to an iron pin on the southwestern side of Hope Street; thence along the southwestern side of Hope Street, S. 38-30 E. 100 feet to the beginning corner; being a portion of the property conveyed to me by Paul Hammond by deed dated August 13, 1954 and recorded in the R.
