NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the séaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Grove Township, on the eastern side of Grove Creek, containing 8.41 acres according to plat of the property made by W.J. Riddle, and more particularly described as follows:

BEGENING at an iron pin in the center of the bridge over Grove Creek at the intersection of road from Piedmont to Moonville, and running along the center of said road, N. 73-35 E. 250 feet to point in center of said road; thence continuing along center of said road, N. 58-30 E. 654 feet to a point in center of road; thence N. 38-15 W. 783.5 feet, more or less, to stake on bank of Grove Creek; thence along Grove Creek 1050 feet to the beginning point.
