take possession of, and for these purposes use, any and all personal property contained in the premises and Morragorin the rental or leasing thereof or, any part thereof. The right to enter and take possession of the and use any personal property therein, to manage, premise and conserve the same, and to collect the rents of profits thereof, whether by a receiver or otherwise, shall be in addition to all other rights or remedies of the barender or affective the same, and to collect the rents of profits thereof in a florded by law, and may be exercised concurrently therewith or independently thereof. 15. Any agreement hereafter made by Mortgagor and Mortgagoe pursuant to this mortgage shall be superior to the rights of the holder of any intervening lien or encumbrance.
