All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being on the Southwestern side of White Horse Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of an unnumbered lot as shown on a plat of Michael Park, prepared by C.C.
