"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, located about two miles north from Greer on the Mosteller Road, containing 3.7 acres, more or less, and being all of Tract No. 4 of the Green Rector Extate, and having the following courses and distances:

BEGINNING at an iron pin on the Mosteller Road, and runs thence S. 75-15 W. 39.5 poles to an iron pin on the Greenville Road; thence N. 26-30 E. 41.5 poles to a ph on the Mosteller Road at intersection of said roads; thence with the Mosteller road, S. 35-00 E. 32 poles to the beginning corner.
