"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 8-AA, being known and designated as Lot No. 45 of a subdivision known as Morgan Hills Addition, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book A, at pages 68 and 69, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Morgan Street at the corner of Lot No. 46, which point is 389 feet West of the intersection of Mona ghan Road, and running thence along the line of Lot No. 46, S. 7 1/4 E. 200 feet to an iron pin at the rear corner of said lot; thence S. 82 3/4 W. 60 feet to an iron pin at the rear corner of Lot No. 44; thence along the line of that lot, N. 7 1/4 W. 200 feet to an iron pin at the corner of said lot on the South Side of Morgan Street; thence along the South Side of Morgan Street, N. 82 3/4 E. 60 feet to the beginning corner.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
