All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the city limits of Greer, on the North side of Mitchell Drive and being known and designated as lot no. Twenty-four (24) of Maple Heights as shown on plat prepared by H. S. Brockman, Reg. Surveyor, dated August 29, 1958 and which plat has been recorded in the R. M. C. Office for said County in Flat Book MM, page 31, and having the following courses and distances, to-wit: Beginning at an Iron Pin on the North side of Mitchell Drive at the joint front corner of lots nos. 23 and 24 as shown on said plat and running thence with the North side of Mitchell Drive S.61-34 b.93 feet to an Iron Pin at the joint front corner of lots nos. 24 and 25 as shown on said plat, thence with the joint property line of said last two mentioned lots N.30-15 b.190.2 feet to an Iron Pin at the joint rear corner of lots nos. 24, 25, 26, and 27 as shown on said plat, thence with the joint property line of said lots nos. 24 and 27 N.61-34 W.93 feet to an Iron Pin at the joint rear corner of lots nos. 23, 24, 27 and 28 as shown on said plat, thence with the joint property line of lots nos. 23 and 24 S.30-15 W.190.2 feet to the beginning point. And being the same property which was conveyed to mortgagor herein by Elmer S. Wilson by deed which will be recorded forthwith in the said office.
