Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of Sixty-four and 45/100 64.45 each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such ances, and then to the payment of principal.
