"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeast

side of Parkins Mill Road (now Mauldin Road) in the block between Waters Avenue and Gurley Avenue, being shown as a portion of an unumbered tract on plat of the property of Pickwick Heights, recorded in Plat Book X at page 141 in the RMC Office for Greenville County and having according to said plat having the following metes and bounds:
