"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Newthwestern side of Woodbriar Court, which iron pin is located 1,214 feet Southwest of Marion Read, and running thence with the Southwestern side of Woodbriar Court, S. 39-25 W., 210.6 feet to an iron pin in senter of a branch, thence with the center line of said branch the traverse of which is N. 22-08 W., 100 feet to an iron pin; thence continuing with said branch N. 27-39 W., 145.1 feet; thence leaving said branch and running W. 44-45 E., 179 feet to an iron pin; thence S. 31-15 E., 217.6 feet to an iron pin on the Northwestern side of Woodbriar Court, the corner of BEGINNING.
