MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, L. C. Craig and Nancy J. Craig, of Greenville County

___(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

therein specified in installments of One Hundred Nine and 54/100----- (\$ 109.54)

Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable25 — years after date; and to the payment of principal with the last payment, if not sooner paid, to be due and payable26 — years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of further sums which may be advanced by the Mortgagoe at and before the sealing of these pre-three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of

Greenville, being shown as Lot No. 69, on a plat of Section III of Wade Hampton Gardens, recorded in the R. M. C. Office for Greenville County in Plat Book YY at Page 179, and described as follows:

BEGINNING at an iron pin on the eastern side of Dagenham Drive, at the corner of Lot 68, and running thence with the eastern side of said Drive, N. 9-46 E. 100 feet to pin, corner of Lot 70; thence with the line of said lot, S. 80-14 E. 160 feet to pin in line of Lot 91; thence with the lines of Lots 91 and 92, S. 9-46 W. 100 feet to pin, corner of Lot 68; thence with the line of said lot, N. 80-14 W. 160 feet to the point of beginning; being the same conveyed to us by W.
