WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of State Highway No. 415 (Green-Locust Hill Highway), about eight miles from the City of Green, bounded by lands now or formerly of J.G. Bradley, C.S. Tate and Ann L. Trammell, and having the following courses and distances, to-wit:
