MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, W. B. Gates, Jr. and Elizabeth P. Gates, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Seven Thousand, Five Hundred and No/100-----(\$ 7,500.00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 226, according to plat of Section A of the property of Woodfields, Inc., a subdivision located on the southwest side of the Augusta Road, which plat was made by the Piedmont Engineering Service on August 29, 1949, and which plat is recorded in the R. M. C. Office for Greenville County in Plat Book W, at page 75, and having, according to said plat, the following metes and bounds, to-wit: BEGINNING, at an iron pin on the northwestern side of Fox Hall Road at the joint front corner of Lots Nos. 225 and 226, and running thence along the line of Lot No. 225, N. 60-42 W. 158.1 feet to an iron pin at the rear corner of Lot No. 225; thence S. 29-18 W. 70 feet to an iron pin at the rear corner of Lot No. 227; thence along the line of Lot No. 227, S. 60-42 E. 162.2 feet to an iron pin on Fox Hall Road; thence along Fox Hall Road, N. 25-54 E. 70.3 feet to the point of beginning; being the same conveyed to the mortgagor, W. B. Gates, Jr., by Ansel Darby by deed dated February 15, 1956 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 545, at Page 383.

ALSO: All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 10 of a subdivision of property of Mrs. H. D. Wilkins according to a plat thereof prepared March 1924 by R. E. Dalton and recorded in the R. M. C. Office for Greenville County in Plat Book F, at Page 209, and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the western side of Elm Street, joint front corner of Lots 10 and 11, and running thence along the western side of said Elm Street, N. 18-00 W. 63 feet to an iron pin at the joint front corner of Lots Nos. 9 and 10; thence with the joint line of said lots, S. 72-00 W. 155 feet to an iron pin in the line of Lot No. 22; thence along the lines of Lots Nos. 22 and 21, S. 15-45 E. 63.05 feet to an iron pin at the joint rear corner of Lots Nos. 10 and 11; thence with the joint line of said lots, N. 72-00 E. 157.5 feet to the point of beginning; being the same conveyed to the mortgagors by Mabel T. Ledford by deed of even date, to be recorded herewith.
