"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot 42, as shown on Map of Anderson Street Highlands, recorded in Plat Book J at page 157 and being more particularly described according to said plat as follows:

BEGINNING at an iron pin at the northern intersection of East Welborn Street and Railroad Avenue and running thence with said Avenue; N. 32-18 E. 131.2 feet to an iron pin at rear corner of Lot 84; thence with line of said lot, N. 47-20 W. 48.2 feet to an iron pin, mar corner of Lot 43; thence with line of said lot, S. 42-40 W. 129 feet to an iron pin on the northeast side of East Welborn Street; thence with said Street, S. 47-20 E. 71.6 feet to the beginning corner.
