BEGINNING at the center of bridge over Shoally creek and running thence with Mack Rice land N. 42-20 W. 168 feet to an iron pin, corner of Rufus Bridwell lot; thence N. 72-33 E. 175.5 feet over pin on bank of road to center of r road; thence along road as property line with W.
