NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeast side of Dakota Road (now Parkins Mill Road), near the City of Greenville, being shown as all of Lot No. 5 on plat entitled 'Section 1, Property of Elizabeth L. Marchant, prepared by Dalton and Neves, Engineers, in January 1961, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book XX at Page 47, and having, according to said plat, the following metes and bounds, to wit:

"BEGINNING at an iron pin on the northeast side of Dakota Road (now Parkins Mill Road), corner of Lots 6 and 5, and running thence along the joint line of said lots, N. 59-57 E. 250 feet to an iron pin; thence N. 30-03 W. 150 feet to an iron pin, joint rear corner of Lots 4 and 5; thence S. 59-57 W. 250 feet to an iron pin on Dakota Road (now Parking Mill Road): thence with said Road S. 30-03 F. 150 feet to the Parkins Mill Road); thence with said Road, S. 30-03 E. 150 feet to the point of beginning."
